CMCO STANDARD OPERATING PROCEDURES (SOP) AS OF 10 MARCH 2021

MOVEMENT CONTROL

- Movement within CMCO areas is allowed - WP Kuala Lumpur and Selangor are considered as one zone and cross movements are allowed.
- Movement to other CMCO, Movement Control Order (MCO), Recovery Movement Control Order (RMCO), Enhanced Movement Control Order (EMCO) areas is not allowed except with the Royal Malaysian Police's (PDRM) approval.
- The number of passengers allowed in vehicles is according to the capacity of the vehicle.
- Activities and services in all airports and ports are allowed to operate.
- Public transport services and e-hailing services are ALLOWED to operate based on vehicle capacity (operating hours according to licence conditions).
- Travelling cross states is allowed for married couples subject to PDRM's approval.

PERMITTED SECTORS

- Fisheries, plantations, agriculture, animal farms, and all industries related to the food supply chain.

RELIGIOUS ACTIVITIES

- Activities in the mosque/surau are allowed with attendance according to the ruling of the State Religious Authorities.
- Activities in non-Islamic religious places are allowed with attendance according to the ruling of the Ministry of National Unity. For Federal Territories, according to the ruling of the Ministry of Federal Territories.

PERMITTED SECTORS: EDUCATION & DAY CARE CENTRES

- Schools, public and private Higher Education Institutions, Industrial Training Institutes, Tahfiz Centres, private kindergartens, and all other private educational centres are allowed to operate according to the guidelines of their respective Ministries/Agencies.
- All education institutions registered with the Ministry Of Education (MOE) can operate subject to the decision and announcement by MOE from time to time.
- Childcare centres, nurseries, kindergartens, disabled (OKU), elderly, and women daycare centres are allowed to operate.
- Parents/guardians are allowed to send their children to daycare centres based on the capacity of the vehicle.
- Students who need to cross states to travel back to campus need to get an approval letter from the relevant educational centres.

OPERATING HOURS: BETWEEN 6 AM - 12 AM

- Restaurants and food stores (Dine-in is permitted with a minimum of 1 metre physical distance between customers taking into account the size of the table).
- Food delivery services
- Supermarkets and Retail Stores
- Petrol stations (24 hours for highway stations)
- Laundrettes
- Spa, reflexology, massage, and wellness centres including pedicure and manicure service

OTHER OPERATING HOURS

- Until 12 AM - Markets according to their licence and permit
- 24 hours/fixed by Government - Clinics & hospitals
- 8 AM until 12 AM - Pharmacies and medicinal shops
- According to licence conditions - Public transport services

PERMITTED SECTORS: CREATIVE INDUSTRY

- All events, shows, performances including government official programs, music, dancing, theatre, musical, comedy, culture and heritage, and live streaming are allowed with audiences limited to 50% capacity of the event space - Restricted to designated locations and licensed event spaces only such as convention centers, exhibition galleries, trade centers, art premises, and other licensed Meetings, incentives, conferencing, exhibitions (MICE) premises.
- Creative Content Development activities including music production, animation, and filming of films, dramas, and documentaries made indoors and outside the studio are permitted subject to 50% capacity.
- The total number of management, artist, and crew is limited to 70% of its original capacity.
- Busking activities in building premises, café, food courts, and shopping malls are permitted.
- Cinema and drive-in cinema activities are allowed.

50% CAPACITY

- Seminars/ Workshops/ Courses/ Training/ Conferences/Talks/ Exhibitions and all related activities of Meetings, Incentives, Conventions and Exhibitions (MICE).
- Government and private, formal and informal events, and social events.
- Face-to-face meetings for official business/work held in offices, hotels, and other institutions.
- Cultural and Tourism Activities to attract tourists.

30% CAPACITY

The capacity of attendance of employees for the public service is based on the Circular/ Instruction of the Public Service Department (JPA). Meanwhile, the private sector is based on 30% for the Management Group and the number of operating/support employees is set by the employer.

SPORTS & RECREATIONAL ACTIVITIES

- Only within the same district as the place of residence in the particular CMCO area.
- All sports and recreational activities are permitted for health, fitness, training games/matches, and local tournaments/competitions without live audiences/supporters.
- Operation of enclosed and semi-closed facilities/premises to be under constant supervisory control during operating hours.
- Local and international tournaments/competitions are subject to the approval of the Ministry of Youth and Sports. Quarantine-Based tournaments/ competitions are permitted without live audiences. The entry of foreign nationals participants into the country is subject to the approval of the Immigration Department of Malaysia (JIM) and supporting documents from the Ministry of Youth and Sports.
- RT-PCR/RTK Antigen tests are mandatory for all involved in the tournaments/competition 3 days before the date of the tournament/competition as required by the SOP for the Sports and Recreational Activities Sector. Only those who are tested negative may participate in the tournament/competition.

PROHIBITED ACTIVITIES

- Movement across other states without the permission of PDRM.
- Involvement of foreign national participants or personnel into Malaysia without permission to enter the country from JIM.
- Sports activities carried out outside the movement-controlled areas in force unless authorised.
- Outbound/inbound tourism activities in MCO areas and EMCO areas.
- Overseas tourism activities by citizens and domestic tourism activities involving foreign tourists entering Malaysia except for foreign tourists from countries specified by the Minister.
- Activities at nightclubs or pubs.
- Tournaments/Competitions with the attendance of live audiences/supporters.
- Tournaments/Competitions without the approval of KBS.
- Physical-contact sports activities carried out more than the 50% capacity of the site with no supervision control.
- Mass activities involve the movement and gathering of many people that make social distancing difficult.
