## ED ACTIVITIES

### Restriction in Movement



- · No interstate and inter-district travel (according to the district borders set by the State Government).
- Movement in/out of the MCO area for emergencies such as in cases of death & natural disasters, with PDRM approval.
- Inter-state and inter-district travel for vaccination purposes is allowed with proof of appointment details.
- Public transport services are ALLOWED to operate based on vehicle capacity (operating hours according to license conditions) with adherence to SOP.
- Travelling cross states is allowed for married couples subject to PDRM's approval.
- complexes/supermarkets/department customers only need to perform a body temperature scan once at the entrance of the complex and not at every business premise under one complex.
- The maximum number of customers allowed entry at any one time must be displayed outside the premises.
- MPs and State Legislative Assemblies allowed to travel across respective districts and states for official purposes or for visitation.
- Internal face-to-face meetings for Government and private agencies not involving the attendance of representatives from external agencies. Meeting attendees must be from the same premises, office or building and does not involve inter-district or interstate travel.

#### Travel & Health



- For travel back and forth to the workplace (company vehicle), according to the capacity of the vehicle.
- Number of passengers in private vehicles, taxis and e-hailing limited to 3 pax only (including driver) for purposes of obtaining health or medical care, food supply, medicine, dietary supplements, food, daily and basic necessities, in the same district closest to their residence if there is no supply of said necessities in said area.
- Activity and services in all airports and ports

#### Day Care Centres





- Childcare centres, nurseries, kindergartens and child development centres for children between 4 to 6 years allowed to operate accordance with the SOP set by the Ministry/Agency.
- Parents/guardians are allowed to send their children to daycare centres according to the capacity of the vehicle.
- Various daycare and rehabilitation centres for the disabled (OKU), senior citizens and women are allowed to operate.

#### Economic and Business Sectors

- All economic and business sectors approved by the relevant Ministries/Agencies can operate during MCO period.
- Approval to operate subject to risk assessment by KKM against the list reported under the Hotspot identification for Dynamic Engagement (HIDE).
- Employee movement is subject to registration/operational approval letter and employee pass/employer confirmation letter.
- Movement in relation to Governmental official affairs must be accompanied by the relevant documents, official Government letter or employee pass.
- Attendance capacity of employees for the civil service is based on the Public Service Department (JPA) Circular/Instruction.
- Capacity of attendance in the private sector is based on 30% Management and the number of operating/support employees set by the employer.

#### Restricted Activities

- Restaurant and food store dine-ins
- Spa, reflexology, massage centres and pedicure/manicure services Activities at nightclubs or pubs, theme parks, indoor playgrounds, karaokes,
- family entertainment centres, and cinemas. Tourism activities involving interstate or inter-district travel
- · Tourist attractions such as zoo, farms, aquariums, edutainment centres,
- extreme/adventure/nature parks etc Art, culture and heritage centres
- · Operation of sports and recreational facilities except public parks subject to
- **Local State Authorities.** · Contact and group sports and recreational activities
- · Face-to-face meetings for Government and private agencies involving the attendance of representatives from external agencies.

• Government and private, formal and informal events, and social events.

- Seminars/Workshops/Courses/Training/Conferences/Talks/ Exhibitions and all related MICE activities.
- Indoor or outdoor busking activities, Hotel lounge performances
- Mass activities

#### Education

- Public and Private Institutes of Higher Education, Skills Training Institutes, Tahfiz Centres and other education institutes closed for 4 weeks from 12 May to 7 June 2021.
- All schools under KPM, private education institutes categorised as schools and centres, and other educational institutes registered under KPM will be closed for 4 weeks from 12 May to 7 June 2021.
- Only international and expatriate school students involved in international examinations allowed to sit for in-person examinations according to the set examination schedule by International examination boards.
- Sending of students based in dormitories are allowed in stages as set by the Department of State Education. Interstate and inter-district travel allowed for such purpose with approval.
- International examinations, professional bodies and research activities that require laboratory facilities in Institutions of Higher Education are
- Face-to-face teaching and learning activities only for students in need
- Movement of lecturers/teachers/teaching staff for teaching and learning is allowed with the relevant Ministry's approval.

## Creative Industry

- Studio recording activities for music, concerts, film making, talk shows and such similar activities are permitted within the studio, limited to within the particular MCO area with the total number of crew members kept to a minimum and with no live audiences in compliance with the SOP for Creative Industry.
  - Drive-in cinemas are allowed

#### Sports and Recreation

- Individual and non-contact sports and recreational activities in open areas limited to jogging, cycling and exercise only with social distancing and within residential neighbourhoods within the same district.
- Quarantined Camp Based Training by National and State Sports Councils & Home Based Training or Camp Based Training for teams in MFL.
- Organisation of tournaments, competitions and friendly matches without audience for MFL only with approval from
- Participation of Malaysian players, participants, officials and technicians in international competitions with the support of KBS and the approval of JIM.

#### Other Activities

- **Driving Institutes, Flight Training and Maritime Centres** according to the SOP issued by the Ministry of Transport
- Fishing for the purposes of maintaining one's livelihood

## Religious Activity



- Muslim: Solat Jumaat, Solat Sunat Aidilfitri and activities in the mosque/surau such as jemaah prayers, with not more than 50 pax for mosque/surau with a max capacity of 1,000 and not more than 20 pax if max capacity is less than 1000, according to the ruling of the State Religious Authority.
- Islamic wedding ceremonies in the religious department and mosque with attendance and burials allowed in accordance with the ruling of the State Religious Authority.
- Non-Muslim: Activities in non-Islamic religious places and burials allowed according to the ruling of the Ministry of **National Unity.**
- The registration of marriages for non-Muslims at the National Registration Department (JPN), House of Worship and Religious Associations is allowed with attendance as determined by JPN.



## Hours of Operation

#### **Operations from 6am to 10pm:**

- Restaurants, shops/food stalls, food trucks, street vendors, mobile vendors, food court/complex and roadside stalls/kiosks for takeaway, drive throughs and deliveries only.
  - **Pharmacies**
- Sundry shops, convenience stores and shops selling daily necessities
- Animal clinics and shops selling pet food Laundrettes, self-service laundrettes car washing, optical
- shops, barber shops and salons (haircut services only)
- Petrol stations (Exception: 24 hours for highway stations)

#### Other Hours of Operation: 24 hours or according to operating license for hospitals,

- clinics and medical laboratories Daily markets, farmers' markets, public markets and
- weekly markets from 7am 2pm
- Wholesale markets from 12am 6am and from 11am 4pm Night markets from 4pm - 10pm
